- c) Subscriptions, contributions and / or donations to any schools, colleges, public funds, orphanages or other public institutions for advancement and propagation of education and knowledge and for promotion of any public charitable objects;
- d) Doing any other act that is considered charitable and of general public utility including:
 - (i) Supplying to needy persons food, clothing and other necessities free of charge or at subsidized rates and or cash to enable them to purchase the same or give them monthly allowance and or lump sum in cash;

- f) Providing relief or assistance in the relief operations in the event of natural calamities like floods, cyclones, earthquakes etc.

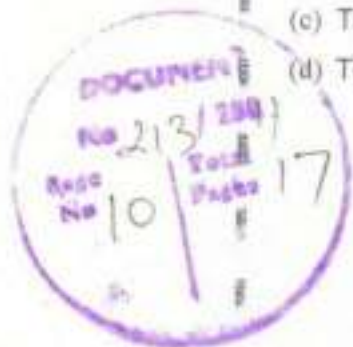

- (a) The Trustees shall receive interest, rent, dividends and profit or loss, other income of the Trust Fund and shall, out of such fund, pay all costs, charges and expenses of and incidental to the management, administration and to the execution of the trust and the powers thereof.
- (b) The balance income remaining after payment as provided in clause 7(a) above, shall be utilised by the Trustees for the objects of the Trust.

16. Without Prejudice to the generality of the powers vested in the Trustees and subject to the provisions of the Income Tax Act, 1961, the Trustees shall have the following specific powers:

- (a) To manage all the affairs of the Trust.
- (b) To invest the Trust Funds in such manner as the Trustees feel in their absolute discretion.
- (c) To cancel, recall or vary all or any of the investments from time to time.
- (d) To enter into agreements, contracts and cancel or vary them.

19. The Trustees shall conduct meetings for the purpose of administration of the Trust as and when they find it necessary and take decision in the meeting including resolution by circulation.
